Ms. Lillie has extensive legal experience as a Trial Attorney in the U.S. Department of Justice, Civil Rights Division and as an Assistant U.S. Attorney in the E.D. PA. She is a former City Solicitor (City Attorney) of the City of Philadelphia and has served on many civic commissions. She is a member of the Executive Leadership Council, The Pennsylvania Women's Forum, The Forum of Executive Women, Delta Sigma Theta Sorority, Inc., and The Links, Inc.
